Notes:

1. First Glory Holdings Limited (“**First Glory**”) directly holds 1,673,810,083 ordinary shares of the Company (representing approximately 74.63% of the existing total issued share capital in the Company). First Glory is a wholly-owned subsidiary of Glory Sunshine Holding Limited (“**Glory Sunshine**”). In turn, Glory Sunshine is wholly owned by HSBC Trustee (Cook Islands) Limited in its capacity as the trustee of Piety Trust (“**Family Trust**”), a discretionary family trust for the benefit of certain family members of Mr. Tang Sing Ming Sherman (“**Mr. Tang**”). Mr. Tang is the founder and one of the beneficiaries of the Family Trust and is deemed to be interested in the said 1,673,810,083 ordinary shares under Part XV of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).
2. Mr. Tang is also the sole legal and beneficial owner of Strong Venture Limited (“**Strong Venture**”), which holds two convertible bonds (“**Convertible Bonds**”) issued by the Company. One was issued in the aggregate principal amount of HK\$3 million pursuant to which a total of 50,000,000 ordinary shares of the Company will be issued upon full conversion at the adjusted conversion price of HK\$0.060 per share and the other one was issued in the aggregate principal amount of HK\$80 million pursuant to which a total of 1,000,000,000 ordinary shares of the Company will be issued upon full conversion at the conversion price of HK\$0.080 per share. Accordingly, Mr. Tang is deemed to be interested, within the meaning of Part XV of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong), in the Convertible Bonds in the aggregate amount of HK\$83 million held by Strong Venture.

Furthermore, Mr. Tang is entitled to 15,000,000 share options of the Company.

- (1) Convertible Bonds: Two different types of unlisted convertible bonds issued by the Company and held by Strong Venture Limited. One was issued in the aggregate principal amount of HK\$3 million pursuant to which a total of 50,000,000 ordinary shares of the Company will be issued upon full conversion at the adjusted conversion price of HK\$0.060 per share and the other was issued in the aggregate principal amount of HK\$80 million pursuant to which a total of 1,000,000,000 ordinary shares of the Company will be issued upon full conversion at the conversion price of HK\$0.080 per share.
- (2) Share Options: Outstanding share options were granted by the Company under the Company's employee share option scheme to subscribe for 48,500,000 ordinary shares of HK\$0.01 each in the share capital of the Company.
